

This Release Notes announcement is for ELD Flex iOS and Android users.

## What's New

### iOS

- Switch/Select Equipment dialog
  - Addition of 'Unlisted' option within the Trailer dropdown selection
  - Selecting the 'Unlisted' option will allow the driver to add Trailer Name and Trailer License Plate
- Canada Regulations
  - Recording of certification events on the day that is being certified, not on the day the certification was performed
  - Edit Logs screen: Removal of Annotate Incorrect Driving button
  - Roadside Inspection screen > Unidentified Driver Profile: Addition of "Start Unidentified Driver Review" button. Once tapped, the following contents of the Unidentified Driver Profile will be displayed:
    - A grid chart showing unidentified drive events only
    - An Event Details section
    - An Engine Power Up and Shut Down section
    - A Diagnostic and Malfunction section
  - Displaying the above events for the current vehicle being used by the logged driver, for the current day and previous 14 days
  - Addition of the following columns in the Roadside Inspection screen, CCMTA PDF and CSV files:
    - Edit Date
    - Edit Time
    - Edit Username (Originator)

### Android

- Addition of 'Removed as Active Driver [(Date Time)]' and 'Assuming Role as Active Driver [(Date Time)]' events for primary/co-driver switching
  - If the driver switches to co-driver, the event 'Removed as Active Driver [(Date Time)]' will be recorded on the primary driver's logs
  - If the co-driver switches to being primary driver, the event 'Assuming Role as Active Driver [(Date Time)]' will be recorded
  - If drive time was reassigned and accepted by a co-driver, the 'Assuming Role as Active Driver [(Date Time)]' event will be recorded along with the accepted drive time and the 'Removed as Active Driver [(Date Time)]' will be recorded along with the inactive-changed drive time on the original driver's logs
- Requiring VBUS Connection when adding Personal Conveyance and Yard Moves for both US and Canada drivers
- Switch/Select Equipment dialog
  - Addition of 'Unlisted' option within the Trailer dropdown selection
  - Selecting the 'Unlisted' option will allow the driver to add Trailer Name and Trailer License Plate

- US Regulations > ELD CSV Output File & eRODS
  - Removal of Exceptions and Annotations from the ELD Event List segment
- Canada Regulations
  - Roadside Inspection screen: Excluding of the Personal Conveyance distance from the distance (Accumulated) column
  - Edit Logs screen: Removal of Annotate Incorrect Driving button
  - ELD CSV Output File & PDF: Removal of Exceptions and Annotations from the ELD Event List segment

## Bug Fixes

- **iOS:**
  - Fixed an issue where the automatic Driving event was being duplicated.
  - Fixed an issue where the added event's time after clearing the Personal Conveyance was being counted as Off Duty hours.
  - Fixed an issue where the Engine Sync Malfunction was not being auto-cleared.
  - Fixed an issue where the unit of distance on the Cargo Check dialog was being displayed in Miles instead of Kilometers.
  - Driver Logs drawer: Fixed an issue where the Miles Driven was incorrect for the co-driver.
  - Change Status dialog: Fixed an issue where the Note field was being required when switching status while in Canadian ruleset.
  - Change Status dialog: Fixed an issue where the Personal Conveyance and Yard Moves buttons were grayed out on the Change Status dialog when Driver's 'Can edit logs' permission was disabled on the portal>Drivers Management page.
  - Select/Switch Equipment dialog: Fixed an issue where the keyboard covers the Trailer dropdown selection using iPhone devices.
  - DVIR screen: Fixed the issue where every DVIR point was a minor defect.
  - Roadside Inspection screen > Send Emails Logs: Fixed an issue where the emailed Certified Driver Logs PDF was in English even if the selected language was French.
  - Roadside Inspection screen > DVIR History: Fixed an issue where the inspections from different drivers and vehicles were displaying when the current vehicle was "None."
  - Settings screen: Fixed an issue where the "About" text was not translated correctly.
- **Android:**
  - Fixed an issue where the added event's time after clearing the Personal Conveyance was being counted as Off Duty hours.
  - Fixed an issue where deactivating manual events causes the event next to it to be deactivated as well.
  - Fixed issue where 'AgriculturalOperations' events weren't being properly converted into annotations for ERODS.
  - Fixed an issue where the dialog "You exceed 172.61692 air-mile" for Short Haul exception is being prompted once the first duty status' lat/long is 1001/1000.
  - Switch/Select Equipment dialog: Fixed an issue where the 'Manage' button is not visible.
  - Roadside Inspection screen > DVIR History: Fixed an issue where the inspections from different drivers and vehicles were displaying when the current vehicle is "None."
  - DVIR screen: Fixed an issue where the severity level was being displayed on the DVIR item that was

previously marked as N/A.

- Time Remaining dialog: Fixed an issue where the Time Remaining was incorrect after being On Duty for almost 14 hours.
- Time Remaining dialog: Fixed an issue where the time spent in Well Site was being counted under Shift clock.
- Fixed an issue where the Agricultural Operations exception was not removed after performing DVIR.
- Fixed an issue where there was no 34hr cycle reset when the last event is Removed Exception Remark for Agricultural Operations.
- Fixed an issue where the Time Until Break value was displaying 400,000 on the app and 2,400,000.00 on the portal>Drivers page.
- Fixed an issue upon logging in to the app where an error has occurred: "Some accounts failed to sync" while syncing driver\_calc.
- Fixed an issue where some of the texts were in English even if the selected language was French.
- Fixed an issue where the Split Sleeper in Alberta cycle was not working when the total time spent was 8 hours.
- Fixed an issue where the ClearYM event was causing inconsistent clocks, statuses, and violations on the portal and the application.
- Fixed issue of invalid 2hour off-duty not part of core 8 violation being triggered.
